- The information shown in these slides is taken from our Trustee's report & Financial Statements which is available on our website




## Financial Review 2015/2016

- Operating surplus of £23,583 after transfers to reserves (our savings)




## Where does our income come from?






## Summary of income over the last 12 years

## UPSU Income 2005 to 2016 £000's







#### **UPSU Expenditure**


#### **Expenditure £'s**






## Representation expenditure

#### Representation total costs (incl allocation of support costs) £000's






## **Welfare: Advice Centre expenditure**

















## **Commercial Income over the last 11 years**



## **SUMMARY**

2015/16 has been a successful year, however we have seen a reduction in our retail (commercial income) due to the impact of CEP & external competition, we have managed this reduction well and our financial security continues to be strong.

Despite some ongoing financial challenges including unprecedented increases in our pension deficit and ongoing increases to our underlying costs, we still aim to further strengthen this position in 2016/17. In order to reduce risk to the organisation and its trustees we are changing the legal form of the SU next year, we will remain a charity but also become a company limited by guarantee (CLG).
