## **EXTRACT OF MINUTES 1ST MAY 2018**

## Know the Line

James Warren- - VP Welfare, gave an overview of the proposal. James noted that the previous training had been criticized and was not therefore not used last year. However, the brand of Know the Line is established and is still referred to in the university.

James had refreshed the training which has been well received by the clubs and societies he had delivered it to. James added that students were not aware of the Safe Taxi scheme and it needed to be better promoted.

James continued to explain that he had intentionally suggested that the Sabbatical team work on this together, rather than one specific officer, as his idea was that Know the Line could be used as an umbrella brand for related issues.

Charles Markham – School of Medicine Rep, asked for clarification as to what themes would be included under the umbrella 'Know the Line'. Charles cautioned the use of 'just say no' campaigns around the use of alcohol and drugs as they are not successful. People are far less likely to come forward and ask for support if they perceive a zero tolerance response.

James clarified that he envisaged the branding being used for wider themes, not just sexual assault and agreed with Charles that a harm reduction approach is more successful than one of zero tolerance.

Philippa Williams – VP Sport pointed out that using the Know the Line for other areas such as drugs and alcohol needs to clear in the policy proposal. Detailed information needs to be given if this is the intention.

Lowri Jones – President expressed concern about everything falling under one, general campaign. Specific campaigns are needed for consent/Know the Line and they need to be kept up to date and relevant.

Goda Cegialyte- Part-time LGBT+ Officer suggested that Ask Angela be added to the presentation.

James explained that, whilst the roll out of the Ask Angela information should have been through PubWatch, circulation of information has been poorly managed and not all the relevant detail has been provided. It was noted that whilst it does fall under the remit of a Sabbatical Officer to influence campaigns through PubWatch, they cannot solely be held responsible for the implementation of such campaigns. James agreed to feedback concerns to PubWatch.

James Lord, Chair of Accountability Board noted that the scheme should also be in place in UPSU's partner nightclubs
